**NOTICE OF LEAD COUNSEL’S MOTION FOR AN AWARD OF  
ATTORNEYS’ FEES AND PAYMENT OF EXPENSES**

PLEASE TAKE NOTICE that Labaton Keller Sucharow LLP, Court-appointed Lead Counsel in the above-captioned class action (the “Action”), will move this Court on August 20, 2026 at 2:00 p.m. EDT, before the Honorable Arun Subramanian, in Courtroom 15A of the United States District Court for the Southern District of New York, Daniel Patrick Moynihan United States Courthouse, 500 Pearl Street, New York, NY 10007, for entry of an Order, pursuant to Rules 23(h) and 54(d) of the Federal Rules of Civil Procedure and the Private Securities Litigation Reform Act, 15 U.S.C. §78u-4(a)(4) (“PSLRA”): (i) awarding attorneys’ fees in the amount of 32% of the Settlement Fund; (ii) awarding Litigation Expenses in the amount of \$759,672.80, plus accrued interest, incurred in prosecuting the Action; and (iii) approving \$21,995.21, in the aggregate, as reimbursement to Lead Plaintiffs Macomb County Employees’ Retirement System, Macomb County Retiree Health Care Fund, and Wayne County Employees’ Retirement System, directly related to the time they dedicated to representing the Settlement Class, as authorized by the PSLRA.

PLEASE TAKE FURTHER NOTICE that in support of this motion, Lead Counsel submits and is filing herewith: (i) the Memorandum of Law in Support of Lead Counsel’s Motion for an Award of Attorneys’ Fees and Payment of Expenses, dated July 16, 2026; and (ii) the Declaration of Michael P. Canty in Support of (I) Lead Plaintiffs’ Motion for Final Approval of Class Action Settlement and Plan of Allocation and (II) Lead Counsel’s Motion for an Award of Attorneys’ Fees and Expenses, dated July 16, 2026, with annexed exhibits.

A proposed Order will be submitted with Lead Counsel’s reply submission on or before August 13, 2026, after the deadline for objecting has passed.
